LEDO joint stock company for the production and trade of ice cream and frozen foods, Čavićeva 9, MBS: 080002964, OIB: 87955947581, represented by authorized person: Tomislav Kitonić, residing in Bojana, Bojana 2 (hereinafter: the Issuer) on 7<sup>th</sup> May 2013, received a notification from Raiffeisen Mandatory Pension Fund Management Company Plc., Zagreb, Heinzelova 44, MBS: 080406381, OIB: 14148900600, represented by authorized person: Srećko Žganec, residing in Zagreb, Dobri Dol 46, that a conversion of the ordinary shares of the Issuer had been made on behalf of and for the account of Raiffeisen Mandatory Pension Fund.

Raiffeisen Mandatory Pension Fund Management Company Plc. informed the Issuer that on 2<sup>nd</sup> May 2013, on behalf of and for the account of Raiffeisen Mandatory Pension Fund, a conversion was made, of 18.750 ordinary shares, ticker LEDO-R-B, (ISIN: HRLEDORB0002), of the company Ledo d.d. into the ordinary shares of the Issuer, ticker LEDO-R-A, (ISIN: HRLEDORA0003), representing 5,97% of the share capital of the Issuer.

After the aforementioned conversion, Raiffeisen Mandatory Pension Fund holds a total of 19.015 shares of LEDO-R-A, representing 6,06% of the share capital of the Issuer.
